



Lupine Racing Ltd. Package Event Supplementary Terms and Conditions

1. Application of These Terms

These Supplementary Terms apply to any Lupine Racing Ltd. Event that includes accommodation and or other travel related services as part of a combined offering.

Such Events may constitute a “package” within the meaning of the Package Travel and Linked Travel Arrangements Regulations 2018. For these Events, Lupine Racing Ltd. acts as the organiser.

These terms apply in addition to the standard Lupine Racing Ltd. Terms and Conditions and shall take precedence where there is any inconsistency.

2. Booking and Payment

A booking is confirmed upon receipt of the required deposit.

The deposit is non refundable except where a refund is required under applicable law.

The remaining balance must be paid no later than 12 weeks prior to the Event start date.

If the balance is not paid by this deadline, Lupine Racing Ltd. reserves the right to terminate the booking and reallocate the place. In such circumstances, no refund of the deposit shall be made.

3. Price and What Is Included

The total price of the Event and details of what is included will be provided prior to booking.

Unless expressly stated, the Event price includes only:

- *accommodation as specified*
- *event organisation and included activities*

Transport to, from, or during the Event is not included unless explicitly stated.

Participants are responsible for any additional costs not included in the Event description.

4. Changes by the Participant

Participants may transfer their booking to another person, provided that:

- *reasonable notice is given*
- *the replacement participant meets all participation requirements*
- *any additional costs incurred by Lupine Racing Ltd. or suppliers are paid*

Both the original and replacement participant shall be jointly responsible for any outstanding amounts.

5. Changes by Lupine Racing Ltd.

Lupine Racing Ltd. may make minor changes to the Event at any time.

Where a significant change is required, Lupine Racing Ltd. will inform participants as soon as reasonably possible.

Where required under the Package Travel and Linked Travel Arrangements Regulations 2018, participants will be offered appropriate remedies, which may include:

- *accepting the change*
 - *accepting a suitable alternative*
 - *cancelling the booking with a refund*

6. Cancellation by the Participant

If a participant cancels their booking:

- *the deposit remains non refundable*
- *additional sums may be retained where necessary to reflect costs already incurred and losses resulting from the cancellation*

The participant may instead transfer their place in accordance with clause 4.

Participants are strongly advised to obtain travel insurance covering cancellation.

7. Cancellation by Lupine Racing Ltd.

Lupine Racing Ltd. may cancel the Event where:

- *the minimum number of participants is not reached*
- *circumstances beyond its control prevent the Event from taking place*

In such cases, participants will be entitled to a full refund of payments made, in accordance with the Package Travel and Linked Travel Arrangements Regulations 2018.

Lupine Racing Ltd. shall not be liable for additional costs or losses incurred by participants beyond those required by law.

8. Performance of the Package

Lupine Racing Ltd. is responsible for the proper performance of the travel services included in the Event.

If any part of the Event is not performed in accordance with the contract, participants must inform Lupine Racing Ltd. without undue delay so that the issue can be addressed.

Where a significant proportion of the services cannot be provided, Lupine Racing Ltd. will offer suitable alternative arrangements where possible.

9. Accommodation and Suppliers

Accommodation and other services are provided by third party suppliers.

Lupine Racing Ltd. will exercise reasonable care and skill in selecting suppliers.

Lupine Racing Ltd. reserves the right to substitute accommodation or services where necessary, provided that alternatives are of a comparable standard where reasonably possible.

Participants are responsible for:

- *any damage caused to accommodation or third party property*
 - *compliance with supplier rules and local laws*

10. Insolvency Protection

In accordance with the Package Travel and Linked Travel Arrangements Regulations 2018, Lupine Racing Ltd. provides protection for the refund of payments made by participants in the event of insolvency.

Details of the applicable insolvency protection arrangements will be provided prior to booking.

11. Limitation of Liability

Nothing in these Supplementary Terms limits liability where it cannot be excluded under law.

Subject to that:

- *Lupine Racing Ltd. shall not be liable for losses that are not a foreseeable consequence of a breach*
- *Lupine Racing Ltd. shall not be liable for losses arising from the participant's own actions or omissions*

All liability is subject to the limits permitted under the Package Travel and Linked Travel Arrangements Regulations 2018.
